

REGLEMENT 13. KUFILMFESTIVAL JENA 24. 29. APRIL 2012

The 13th Short Film Festival Jena takes place from April 24th to 29th, 2012. We cordially invite all filmmakers and filmfans to send in works from all genres.

The arrangement of contents is done by the host of the Short Film Festival Jena, the cellu l'art-Festival Jena e.V.

The festival management decides on the selection of each section and invites for participation. Deadline for registration will be 3rd February 2012 (arrival at our office).

The films for the competition have to be produced after 1st January 2011.

Work from all categories (feature films, documentaries, experimentals, animations, music videos etc.) and genres with a maximum length of 25 minutes can be handed in. All films exceeding the allowed length can only be accepted in exceptional cases. The organisers decide about exceptions. There is no legal claim for participation. The festival management or the ones being authorised by it decide on the selection and planning of the films.

Participation in the competition is possible for: Films made in the formats: blu-ray, DigiBeta and BetaSP and also DVD. The preview copy has to be handed in as DVD. Every copy has to be firmly signed (title, director, length, format and sound and/or music) and provided with the official entry form.

Every film is shown in the original language. Films that are not in German or English need to be subtitled in one of these languages.

The screening copies for the competition have to be sent in until April 16th, 2012 to the cellu l'art-Festival Jena e.V.

By submitting a contribution for the competition a fee of 5 Euros is raised to cover mailing expenses of the cellu l'art-Festival Jena e.V. The fee has to be paid until 3rd February 2012 onto one of the following bank accounts:

The reason for transfer is "festival fee 2011" and the title of the film. Exceptions concerning the paying of the fee are not possible.

Costs caused of the transmittals of the materials have to be paid by the participants. Transmittals causing costs for the organiser are being refused acceptance. All films have to be send to:

Costs for sending back the materials are paid by the Short Film Festival Jena. Changes of the filmmaker's address can only be considered until 16th April 2012. Preview copies remain in the organiser's archive. Patent utilisation for own events of the cellu l'art-Festival Jena e.V. remain at the organiser's side.

The films are covered by insurance while being in Jena. Insurance counts from the time of the arrival of the film in the festival office until the return forwarding. In the event of damage costs of material for the copy are being compensated in relation to the origin country and after presenting a bill. Goodwill compensation is excluded.

The sender agrees that of parts of his/her work can be used for journalistic coverage (radio/TV) and the online presence of the host.

The sender confirms to be the owner of the rights of the submitted in work.
